1. Page 3, Working Group

Amend the last sentence to read "Service providers will need to fulfill the additional requirements pertaining to capability in Clause 5."

3. Page 16, 3.5.4

Amend the 1st sentence to read "The organisation shall establish procedures to ensure the quality and integrity of vendor staff directly involved in support of its recovery services."

4. Page 19, 3.8.2

- a) *Amend* the 1st line of item (e) to read "Consultation with client representative on one of the following courses of action:"
