This Singapore NA contains information on those parameters which are left open in EN 1991-1-5 for national choice, known as nationally determined parameters. The Singapore NA is to be read in conjunction with SS EN 1991-1-5: 2009 – Eurocode 1: Actions on structures – Part 1-5: General actions – Thermal actions.

Temperature profile for temporary earth retaining structural system is not covered in this National Annex. Users may refer to the Singapore Technical Reference for Deep Excavation for the appropriate section on design requirements.

At the time of publication, this standard is expected to be used as a reference in the Building and Construction Authority's 'Approved Document – Acceptable Solutions'.
