National Foreword

This Singapore Standard was prepared by the Working Group on Methods of Test for Paints, Varnishes and Related Materials set up by the Technical Committee on Surface Coatings under the purview of CSC.

It is a revision of SS 5 : Part H5 : 2013 “Methods of test for paints, varnishes and related materials – Part H5: Designation of degree of flaking”.

This standard is a modified adoption of ISO 4628-5:2016, “Paints and varnishes – Evaluation of degradation of coatings – Designation of quantity and size of defects, and of intensity of uniform changes in appearance – Part 5: Assessment of degree of flaking”, published by the International Organization for Standardization. The deviation is as follows:

1 (Scope)	<p>Deleted “ISO 4628-1 defines the system used for designating the quantity and size of defects and the intensity of changes in appearance of coatings and outlines the general principles of the system. This system is intended to be used, in particular, for defects caused by ageing and weathering, and for uniform changes such as colour changes, for example yellowing.”</p> <p><i>Explanation:</i> Paragraph 2 of the scope is not applicable as ISO 4628-1 was not adopted as a Singapore Standard</p>

NOTE 2 – Where numerical values are expressed as decimals, the comma is read as a full point.

1 Scope

This part of ISO 4628 specifies a method for assessing the degree of flaking of coatings by comparison with pictorial standards.

ISO 4628-1 defines the system used for designating the quantity and size of defects and the intensity of changes in appearance of coatings and outlines the general principles of the system. This system is intended to be used, in particular, for defects caused by ageing and weathering, and for uniform changes such as colour changes, for example yellowing.
