Foreword

This Singapore Standard was prepared by the Working Group on Thermal Imagers set up by the Technical Committee on Medical Devices under the purview of BHSC.

The 2013 edition of SS 582 resulted from the review of the Technical Reference, TR 15: Parts 1 and 2. This is a revision of the 2013 edition. The revised standard comprises the following two parts under the general title, 'Specification for thermal imagers for human temperature screening':

- Part 1: Requirements and test methods
- Part 2: Implementation guidelines

A summary of the changes in this revision of Part 2 is given as follows:

- A new definition for "Indoor";
- Updated pictures in Annex B;
- Broadening of deployment cases for Annex C.

Part 2 provides guidelines, examples and deployment cases for the planning and deployment of thermal imagers for non-invasive human temperature screening of large groups of individuals under indoor environmental conditions.

Specification for thermal imagers for human temperature screening – Part 2: Implementation guidelines

1 Scope

This Singapore Standards provides general guidelines for the implementation of thermal imagers for non-invasive human temperature screening of large groups of individuals under indoor environmental conditions.

NOTE – Thermal imagers from different manufacturers would have their own particular operation procedures and it is not the purpose of this standard to regulate the usage of thermal imagers for this application.
