The Singapore NA is to be read in conjunction with the SS EN 1993-1-5 : 2009 – Eurocode 3 : Design of steel structures – Part 1-5 : Plated structural elements.

Where appropriate, users may refer to the guidance and recommendation in BC 1:2008 'Design guide on use of alternative steel materials to BS 5950' published by the Building Construction Authority (BCA).

### NA.2 Nationally determined parameters

#### NA.2.1 Effective width models for global analysis [SS EN 1993-1-5:2009, 2.2(5)]

The recommended value of effective width parameter  $\rho_{lim}$  should be used.

#### NA.2.2 Shear lag at the ultimate limit state [SS EN 1993-1-5:2009, 3.3(1)]

The recommended method in NOTE 3 should be used.

#### NA.2.3 Effective cross section [SS EN 1993-1-5:2009, 4.3(6)]

The recommended value of  $\varphi_h$  should be used.

#### NA.2.4 Basis [SS EN 1993-1-5:2009, 5.1(2)]

The value of  $\eta$  should be taken as 1.0 for all steels.
