## National Foreword

This Singapore Standard was prepared by the Working Group on Waste Collection and Transportation Management set up by the Technical Committee on Circularity of Materials under the purview of the Environment and Resources Standards Committee.

This standard is a revision of SS EN 840-1:2014. It is an identical implementation of EN 840-1:2020+AC:2020, "Mobile waste and recycling containers – Part 1: Containers with 2 wheels with a capacity up to 400 I for comb lifting devices – Dimensions and design" incorporating its Corrigendum, EN 840-1:2020/AC, denoted by AC> <AC, and is adopted with permission of CEN, Rue de la Science 23 B - 1040 Brussels.

For clarity, the 2nd paragraph of the scope should be read as "The containers can only be used with the abovementioned lifting devices.".

With reference to Subclause 9.1, below are some examples of markings of EN 840 containers in Singapore:





This marking shows the year and month of manufacturing:

- The months are represented on the outer part of the circle (1 to 12). The arrow points to the manufacturing month.
- The year of manufacture is represented by two bigger digits in the middle.
- This example shows the marking on a bin manufactured in March 2020.

appropriately designed container fitted with wheels intended to temporarily store waste

#### lifting device

structure which picks-up, tilts and empties containers

## comb lifting device

lifting device in which the picking-up system consists of a row of teeth and a locking system to retain the container during emptying

## 3.4

## volume

total space inside the container when the lid is closed
