With reference to Subclause 9.1, below are some examples of markings of EN 840 containers in Singapore:





This marking shows the year and month of manufacturing:

- The months are represented on the outer part of the circle (1 to 12). The arrow points to the manufacturing month.
- The year of manufacture is represented by two bigger digits in the middle.
- This example shows the marking on a bin manufactured in March 2020.

These containers are only approved for the before explicitly mentioned lifting devices.

appropriately designed container fitted with wheels intended to temporarily store waste

lifting device

structure which picks-up, tilts and empties containers

lifting device in which the picking-up system consists of a row of teeth and a locking system to retain the container during emptying
